The Making of a Commando

In order to understand a creation, it is helpful to understand the mind of the designer. And the mind of a commando has been carefully architected.

In 1975 the public got a glimpse of the secret training delivered to commandos when a Navy psychologist, Lt. Comdr. Thomas Narut, spoke to the London Times during a NATO conference in Oslo on "Dimensions of Stress and Anxiety." The conversation took place just after the Senate Intelligence Committee had reprimanded the CIA for plotting a number of political assassinations around the world.

Narut said that Naval Intelligence had taken convicted murderers from military prisons and conditioned them as assassins, and then placed them in US embassies around the world. He also explained that he had worked with "combat readiness units" which included men being trained for commando-type operations. These, Narut said, were "hit men and assassins" (Narut's words) made ready to kill in selected countries should the need arise.

The potential assassins were identified by evidence of past violence or by psychological tests such as the Minnesota Multiphasic Personality Inventory. Once identified, training of the assassins was accomplished by audio-visual presentations. The prospective commandos were "desensitized" to mayhem by being shown films of people being killed or injured in a number of different ways. At first the films would show only mild forms of bloodshed. As the men became acclimated to the scene of carnage, they would see progressively more violent scenes. The assassin candidates, Narut explained, would eventually be able to disassociate even the goriest scenes from any feelings of repugnance they might have had at first.

At first the men might be shown a film of an African youth being crudely circumcised by tribe members with a blunt knife and no anesthetic. Afterwards the trainee would be asked about inconsequential details of the episode--such as the motif on the handle of the knife used to cut the foreskin.

Next the commando trainees were shown a film of a man in a sawmill, where planks were sliced from huge logs. In the operation of the saw the man slipped and cut off his fingers. As the films progressed in gruesomeness, the reactions of the trainees were measured by sensing devices: heartbeat, breathing rate, and brain waves were recorded. If the physiological responses, which might have been great in the beginning, slowed down and resumed normal patterns as the more bloodthirsty scenes were viewed, the candidates were judged to have completed this stage of conditioning.

The final stage of conditioning was the indoctrination of the future commandos to think of their potential enemies as inferior forms of life. By this stage the commandos would already have been selected for assignment to particular countries. They would be shown films and given lectures which portrayed the customs and culture of the people in a disparaging manner. The people of those countries were presented as enemies of the United States.

It took only a couple of weeks to program the susceptible candidates by this process. Those who did not do well in the conditioning were dropped out of the program and reassigned to other duties. Dr. Narut said he did not have the necessary "need to know" where his trainees were assigned, but did say that his busiest time was when a large group of men went through such training towards the end of 1973, at the time of the Yom Kippur War. ■ DOD, Intel Agencies Look at Russian Mind Control Technology, Claims FBI Considered Testing on Koresh.

Federal law enforcement officials considered testing a Russian scientist's acoustic mind control device on cultist David Koresh a few weeks before the fiery conflagration that killed the Branch Davidian leader and more than 70 of his followers in Waco, Texas, *Defense Electronics* has learned.

In a series of closed meetings beginning March 17 in suburban Northern Virginia with Dr. Igor Smirnov of the Moscow Medical Academy, FBI officials were briefed on the Russian's decade-long research on a computerized acoustic device allegedly capable of implanting thoughts in a person's mind without that person being aware of the source of the thought.

"It was suggested to us [by other federal officials] that they bring in the FBI, which was looking for a viable option to deal with Koresh," said a source who participated in the Smirnov meetings who agreed to discuss the gatherings only on condition of anonymity.

His account of the meetings was confirmed by an executive summary memorandum prepared by officials of Psychotechnologies Corp., a Richmond, Virginia, based firm that owns the American rights to the Russian technology. A copy of the Psychotechnologies summary, which has been circulated among U.S. intelligence executives, was obtained by *DE*.

The Psychotechnologies memo described the standoff between federal agents and Koresh in Waco as "an ongoing domestic hostage situation."

After several meetings with Smirnov, FBI officials, who repeatedly expressed fears during the discussions that Koresh and his followers were suicidal, asked for a proposal describing requirements and procedures for using the de-

vice in Waco, he said.

"They wanted the Russians to promise zero risk" in using the device on Koresh, but the Russians wouldn't do that," the participant said. Another obstacle was the fact Smirnov had only brought "entry-level equipment" and more sophisticated hardware would have had to be rushed over from Russia before the device could be used in an attempt to end the standoff in Texas.

As a result, Koresh and his band were not used as test subjects for a demonstration of a technology developed under the former Soviet Union and apparently used against civilians in Afghanistan, which is why the U.S. defense and intelligence communities were well-represented in the March meetings in Virginia.

"There was a strong interest among the intelligence agencies because they had been tracking Smirnov for years," the participant said, "and because we know there is evidence the Soviet Army's Special Forces used the technology during the conflict in Afghanistan."

Alcohol and drug abuse among Red Army soldiers was so pervasive during the Afghan war that Soviet officials relied upon the technology in preparing troops for missions involving atrocities against civilians.

Officials from the Central Intelligence Agency (CIA), Defense Intelligence Agency (DIA) and the Advance Research Projects Agency (ARPA) were also present, according to the source. Spokesmen for those agencies did not return a reporter's telephone calls seeking to confirm whether individuals from their organizations attended the Smirnov meetings.

Because the U.S. has no known counter-measure to the technology, intelligence community and ARPA officials are concerned that weaponized

versions of the device may still be in the Russian military inventory, and they expressed fear during the meetings that the technology could be exported to Third World nations via the growing black market in military equipment from the former Soviet Union, he said.

The main purpose of the March meetings was described in the Psychotechnologies memo as to "determine whether psycho-correction technologies represent a present or future threat to U.S. national security in situations where inaudible commands might be used to alter behavior."

The memo went on to note that meeting attendees were also interested in whether "psycho-correction detection, decoding and counter-measures programs should be undertaken by the U.S." An effective psycho-correction device could be a military threat, the memorandum continued, if it were deployed to "negatively affect morale of U.S. troops in combat" or to "affect judgement or opinions of decision-makers, key personnel or populaces" in a conflict. Further, the memo said Department of Defense (DOD) officials were concerned that the technology could be used in the protection of U.S. embassies, military training and in non-violently "clearing areas of potential enemies, snipers, etc."

Non-military participants were also included in the Smirnov meetings in Virginia, as well as a series of subsequent briefings by the two Russians at the University of Kansas Medical Center in Topeka. The non-military attendees included Dr. Richard Nakamura of the National Institute of Mental Health and Dr. Christopher Green, director of General Motors Corp. (GM) biomedical research department in Detroit.

Dr. Nakamura could not be reached for comment, but he was described in the Psychotechnologies memo as being "familiar with U.S. patents" in the area and that "the Russians seemed to have solved" mathematical problems "which had prevented development of U.S. work beyond basic stages."

Dr. Green said through a GM spokesman that he attended the Smirnov briefings in his capacity as a member of a National Academy of Sciences (NAS) panel on 21st Century Army technologies. "This has no connection to anything being done by GM," the spokesman said.

"It looks promising, but we don't have enough details yet to really appraise it," Dr. Fowler Jones of University of Kansas Medical Center's psychology division told *DE*. "It was really more of a presentation than an actual demonstration because, unfortunately, a lot of the software we couldn't get going." Jones said he and his colleagues at the Kansas facility are looking for funding sources for research to determine whether the Russian psycho-correction technology can be used in treating alcoholism and other addictions.

The Psychotechnologies memo described an agreement company officials entered into with Smirnov in March in which "the Russian side agreed to commit the psycho-correction technologies still in Russia and all related know-how to the U.S. company in exchange for stock. The Russian side has agreed to provide all support necessary to recreate current [psycho-correction] capability in the U.S. and to upgrade the capability using U.S. components and computer programmers. All necessary developmental and existing algorithms will be provided by the Russian side."

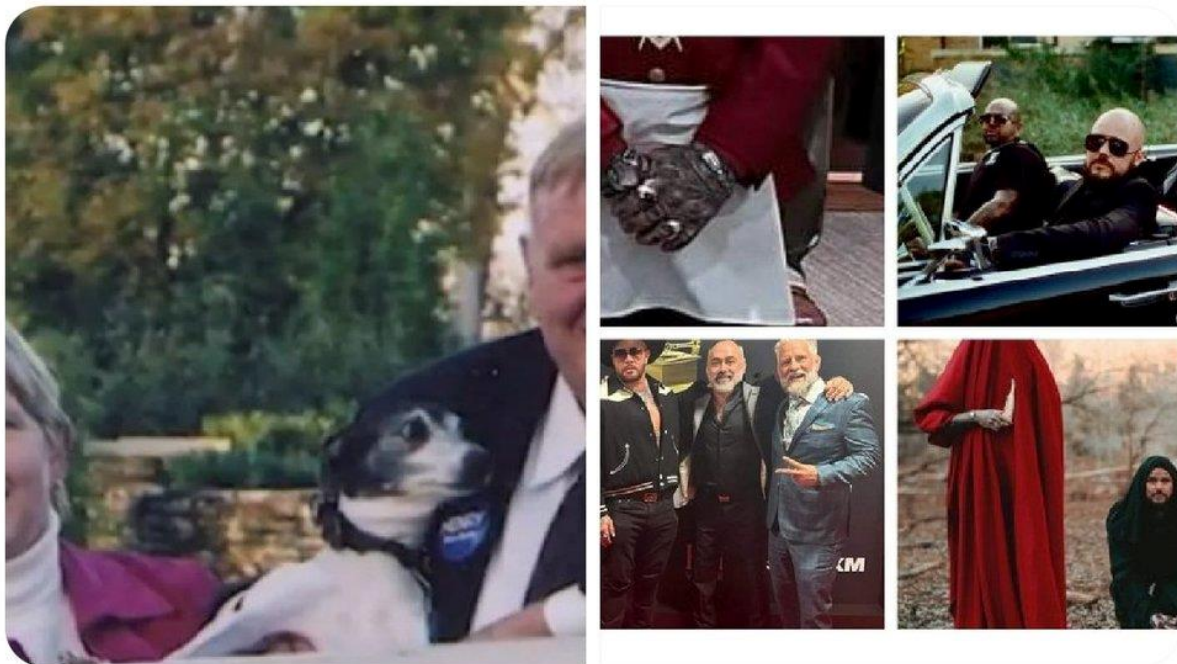

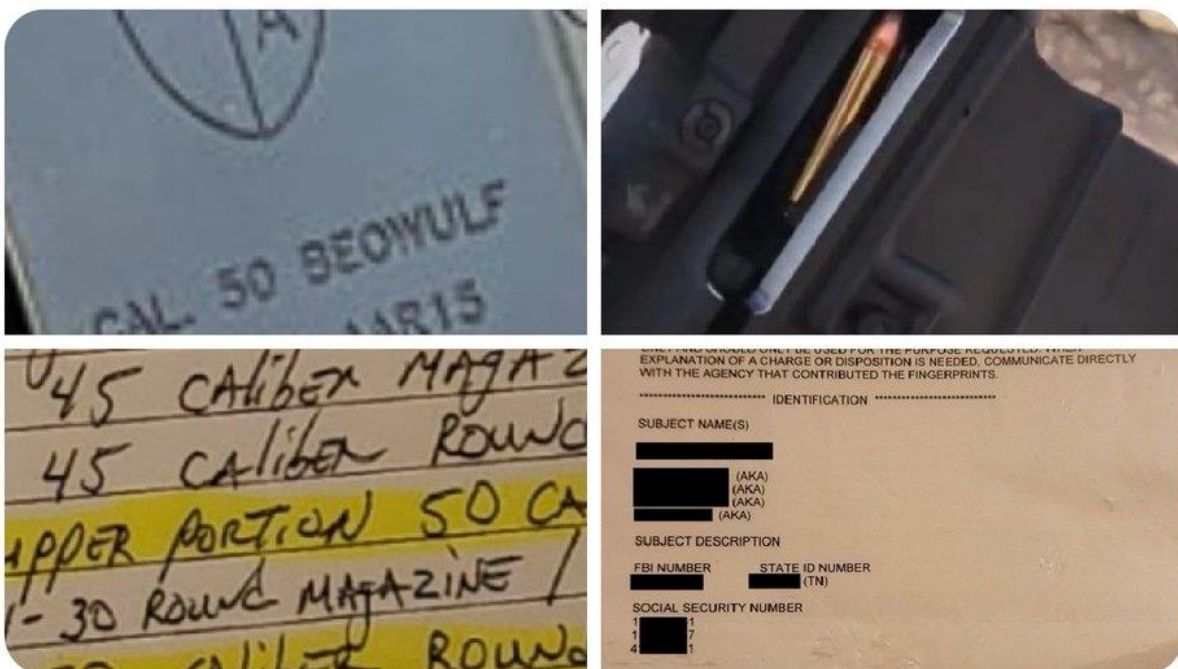

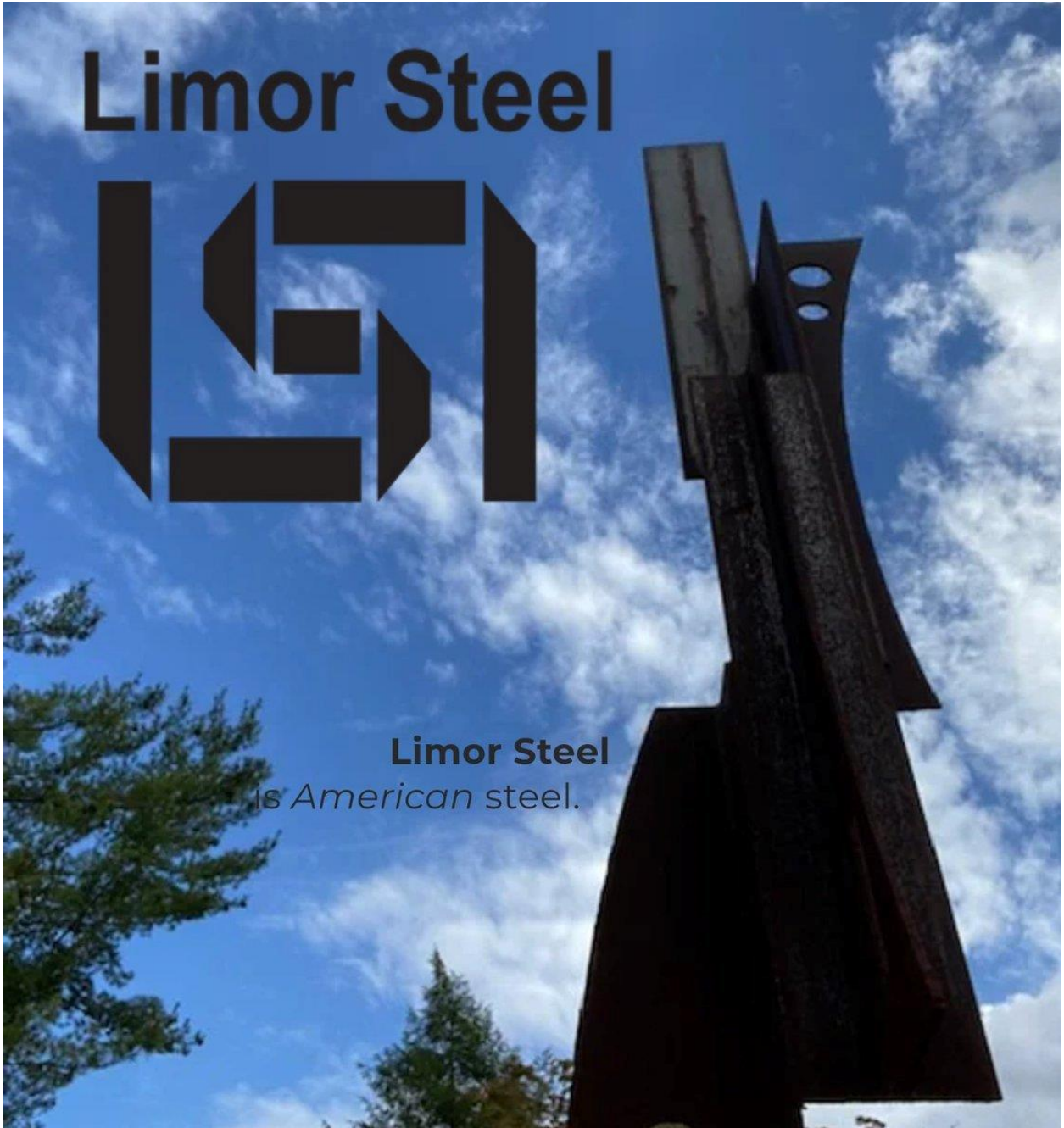

Lieutenant Commander Thomas Narut describes operational and ongoing 'assembly line' brainwashing derived from MKULTRA research: According to the Sunday Times story, naval psychologist Lt. Comdr. Thomas Narut was assigned to the U.S. Regional Medical Center at Naples, Italy. When he first made public the navy's part in programming assassins, he was attending a NATO conference in Oslo on "Dimensions of Stress and Anxiety." In attendance at that conference were 120 psychologists of all descriptions and from many countries. Many of them were involved in research on how to improve man's ability to cope with stress, but none of them felt compelled, as Narut did, to discuss their work so fully or so frankly. The stated objective of the conference was to exchange information on how soldiers and people in difficult jobs could cope with stress. Dr. Narut's talk was on "The Use of a Symbolic Model and Verbal Intervention in Inducing and Reducing Stress." His speech began with a plug for the navy. He knew, he said, that many of the scientists present had often encountered problems in their purely scientific research because of the military's inclination to research that would yield quick and useful results. He sympathized with those who had trouble getting subjects, funds, or both, out of the military for their purely scientific research. But things were different in the navy he said. In the navy, Narut bragged, there were plenty of captive personnel who could be used as guinea pigs. In the navy there was a computerized record of each man's background and psychological profile, so that a quick selection of men with suitable psychological inclinations for experiments could be made. Navy psychologists not only had access to computerized records, but also to psychological tests and background data on a large number of people. In the navy, Narut

said, funds were plentiful, and there were no problems with transporting subjects for study to nearly any place in the world. Narut stated proudly that the U.S. Navy provided scientists with the most advanced research facilities in the world. A Canadian psychologist at the conference later remarked, "Narut's message was loud and clear: - Join the navy and study the world". In his brief discourse, Dr. Narut did no more than hint at the work he had been doing in teaching "combat readiness units" to cope with the stress of killing. Later, however, during private questioning with a small group of listeners (reporter Peter Watson of the Sunday Times, a former psychologist, among them), Narut unfolded the amazing story of the navy's programming of assassins on an assembly-line basis. In his mid-thirties, Dr. Narut had just completed his doctoral dissertation on the question of whether certain films provoke anxiety, and whether forcing a man to do irrelevant tasks while watching violent films would help him cope with the anxiety they produced. When pressed by Watson to explain the details of this kind of conditioning, Narut said that he had worked with "combat readiness units" which included men being programmed for commando-type operations and for undercover placement at U.S. embassies. These, Narut said, were "hit men and assassins" (Narut's words) made ready to kill in selected countries should the need arise. Dr. Alfred Zitani, an American delegate to the conference, was very surprised by Narut's disclosure. "Do you think Dr. Narut realizes what he has just said?" Zitani asked. "That kind of information must be classified." (continued)

The conditioning of Narut's assassins was accomplished by audio-visual desensitization, a standard behavior modification process. These men were "desensitized" to mayhem by being shown films of people being killed or injured in a number of different ways. At first the films would show only mild forms of bloodshed. As the men became acclimated to the scenes of carnage, they would see progressively more violent scenes. The assassin candidates, Narut explained, would eventually be able to dissociate any feelings they might have from even the goriest scenes they viewed. Narut said that of course U.S. naval psychologists would have first selected the candidates for training by their psychological makeup. Those selected for assassination assignments were often from submarine crews and paratroops. Others were convicted murderers from military prisons who had already shown a proclivity for violence. Still others were men who had been given awards for valor. World War II Medal of Honor winner Audie Murphy was a subject of extensive research. The best killers, according to Narut, were men whom psychologists would classify as "passive-aggressive" personalities. These were people with strong drives that were usually kept under tight control. Such types were usually calm, but from time to time would exhibit outbursts of temper during which they could literally kill without remorse. Narut said that through psychological testing, he and his colleagues were looking for more such men, for further conditioning. Among the tests used by the navy to determine violent natures was

the Minnesota Multiphasic Personality Inventory, which is used widely by educators and businessmen to determine psychological qualities of students and employees. The tests consist of hundreds of questions designed to measure such personality traits as hostility, depression, and psychopathy. According to Narut, the men selected by the tests, or by evidence of past violence, were taken for programming to the navy's neuropsychiatric laboratory in San Diego, California, or to the Naples medical center which employed Dr. Narut. Audio-visual desensitization was the major technique used in programming the assassins. Psychological indoctrination completed the programming by instilling the desired prejudicial attitudes. The audio-visual desensitization began with the subject strapped into a chair with his head clamped so that he could not look away from the screen. A special mechanism prevented the subject's eyelids from closing. The candidate was then shown a film of an African youth being crudely circumcised by fellow members of his tribe. The youth was circumcised with a blunt knife, painfully and without anesthetic. This well-known film is used widely in psychological experiments to create stress. Afterwards the candidate was asked about details of what he had seen. He was asked, for example, to describe the color of the belt on the doctor's trousers, or the motif on the handle of the knife that cut off the foreskin. The next film showed a man in a sawmill, where planks were sliced from huge logs. In the operation of the saw the man slipped and cut off his fingers. As the films progressed in gruesomeness, the reactions of the candidate were measured by sensing devices. Heartbeat, breathing rate, and brain waves were recorded, very much as on a polygraph. If the physiological responses, which might have been great in the beginning, slowed down and resumed normal patterns as the more bloodthirsty scenes were viewed, the candidates were judged to have completed this stage of conditioning. (continued)

The last phase of conditioning, Narut said, was to indoctrinate the candidates to think of their potential enemies as inferior forms of life. By this stage, the candidates would have already been selected for assignment to particular countries. They would be shown films and given lectures which portrayed the customs and cultural habits of the foreign countries in a biased fashion. The people of those countries would be portrayed as enemies of the United States and were always spoken of in demeaning terms. They were often presented as if they were "less than human." Their customs were ridiculed, and local leaders were presented as evil demagogues, even if they were legitimate political figures. Naval Hospital Naples Corpsman Awarded Bronze Star, but they doesn't look proud or even glad. According to Dr. Narut it took only a few weeks to indoctrinate susceptible candidates by this process. Those who were not susceptible to the conditioning were dropped earlier in the program and returned to other assignments. Narut admitted that he did not have the necessary "need to know" as to where all the programmed men were sent, although at one

point in his conversation with Peter Watson, Narut specified that programmed assassins have been installed in the Athens embassy. He said that his busiest time was when a large group of men went through such training towards the end of 1973, at the time of the Yom Kippur War. After the Oslo conference interview, Watson returned to London to file his story. Writing up the details, he found a few points which needed clarification but he could not reach Narut either at his home or in his laboratory in Naples. Watson then asked the U.S. embassy in London to comment on the information Narut had volunteered. The embassy passed the buck to the U.S. Navy. Within a few days the Pentagon issued a categorical denial that the U.S. Navy had ever "engaged in psychological training or other types of training of personnel as assassins." They also denied that any such training had ever taken place either in San Diego or in Naples. They said they too had been unable to contact Lieutenant Commander Narut, but they did confirm that he was on the staff of the U.S. Regional Medical Center in Naples as a psychologist. But Dr. Zitani later offered to testify about what Narut had told him to appropriate authorities." Watson was also approached later by a psychologist in Los Angeles who said he had seen the Pentagon denials so thought Watson would like to know that he had lent the San Diego psychologists a copy of his film on circumcision which was used in the desensitization conditioning. A few days later Narut was located. He flew to London to discuss the matter ostensibly with Watson's paper, the Sunday Times, but instead he held a press conference saying only that he had been talking in "theoretical and not practical terms." He then flew back to the Naples base. After his return to Naples, U.S. naval headquarters in London offered the official explanation for Narut's statement: Narut had "personal problems." A few days later Watson was able to contact Narut at the U.S. hospital in Naples, but he refused to elaborate on his disclosure. (continued)

Illinois Statute - Ritualized abuse of a child (720 ILCS 5/12-33) (from Ch. 38, par. 12-33) Sec. 12-33. Ritualized abuse of a child. (a) A person commits ritualized abuse of a child when he or she knowingly commits any of the following acts with, upon, or in the presence of a child as part of a ceremony, rite or any similar observance: (1) actually or in simulation, tortures, mutilates, or sacrifices any warm-blooded animal or human being; (2) forces ingestion, injection or other application of any narcotic, drug, hallucinogen or anaesthetic for the purpose of dulling sensitivity, cognition, recollection of, or resistance to any criminal activity; (3) forces ingestion, or external application, of human or animal urine, feces, flesh, blood, bones, body secretions, nonprescribed drugs or chemical compounds; (4) involves the child in a mock, unauthorized or unlawful marriage ceremony with another person or representation of any force or deity, followed by sexual contact with the child; (5) places a living child into a coffin or open grave containing a human corpse or remains; (6) threatens death or serious harm to a child, his or her parents, family, pets, or friends that instills a well-founded fear in the child that the threat will be carried out; or (7) unlawfully dissects, mutilates, or incinerates a human corpse. (b) The provisions of this Section shall not be construed to apply to: (1) lawful agricultural, animal husbandry, food preparation, or wild game hunting and fishing practices and specifically the branding or identification of livestock; (2) the lawful medical practice of male circumcision or any ceremony related to male circumcision; (3) any state or federally approved, licensed, or funded research project; or (4) the ingestion of animal flesh or blood in the performance of a religious service or ceremony. (b-5) For the purposes of this Section, "child" means any person under 18 years of age. (c) Ritualized abuse of a child is a Class 1 felony for a first offense. A second or subsequent conviction for ritualized abuse of a child is a Class X felony for which an offender who has attained the age of 18 years at the time of the commission of the offense may be sentenced to a term of natural life imprisonment and an offender under the age of 18 years at the time of the commission of the offense shall be sentenced under Section 5-4.5-105 of the Unified Code of Corrections. (d) (Blank). (Source: P.A. 99-69, eff. 1-1-16.)ilga.gov/legislation/il...

Montana Statute - Ritual Abuse Of Minor 45-5-627. Ritual abuse of minor -- exceptions -- penalty. (1) A person commits the offense of ritual abuse of a minor if the person purposely or knowingly and as part of any ceremony, rite, or ritual or of any training or practice for any ceremony, rite, or ritual: (a) has sexual intercourse without consent with a person less than 16 years of age; commits assault, aggravated assault, assault on a minor, or assault with a weapon against a victim less than 16 years of age; or kills a person less than 16 years of age; (b) actually or by simulation tortures, mutilates, or sacrifices an animal or person in the presence of the minor; (c) dissects, mutilates, or incinerates a human corpse or remains in the presence of the minor; (d) forces upon the minor or upon another person in the presence of a minor the ingestion or the external bodily application of human or animal urine, feces, flesh, blood, bone, or bodily secretions or drugs or chemical compounds; (e) places a living minor or another living person in the presence of a minor in a coffin or open grave that is empty or that contains a human corpse or remains; or (f) threatens the minor or, in the presence of the minor, threatens any person or animal with death or serious bodily harm and the minor reasonably believes that the threat will or may be carried out. (2) This section does not apply to activities, practices, and procedures otherwise allowed by law. (3) Except as provided in 46-18-219, a person convicted of ritual abuse of a minor shall: (a) for the first offense, be imprisoned in the state prison for a term of not less than 2 years or more than 20 years and may be fined not more than \$50,000, or both; and (b) for a second or subsequent offense, be imprisoned in the state prison for any term of not less than 2 years or more than 40 years and may be fined not more than \$50,000, or both. (4) In addition to any sentence imposed under subsection (3), after determining pursuant to 46-18-242 the financial resources and future ability of the offender to pay restitution, the court shall require the offender, if able, to pay the victim's reasonable costs of counseling that result from the offense. The amount, method, and time of payment must be determined in the same manner as provided for in 46-18-244.leg.mt.gov/bills/mca/titl...

Idaho Statute - Ritualized Abuse of a Child 18-1506A. RITUALIZED ABUSE OF A CHILD — EXCLUSIONS — PENALTIES — DEFINITION. (1) A person is guilty of a felony when he commits any of the following acts with, upon, or in the presence of a child as part of a ceremony, rite or any similar observance: (a) Actually or in simulation, tortures, mutilates or sacrifices any warm-blooded animal or human being; (b) Forces ingestion, injection or other application of any narcotic, drug, hallucinogen or anaesthetic for the purpose of dulling sensitivity, cognition, recollection of, or resistance to any criminal activity; (c) Forces ingestion, or external application, of human or animal urine, feces, flesh, blood, bones, body secretions, nonprescribed drugs or chemical compounds; (d) Involves the child in a mock, unauthorized or unlawful marriage ceremony with another person or

representation of any force or deity, followed by sexual contact with the child; (e) Places a living child into a coffin or open grave containing a human corpse or remains; (f) Threatens death or serious harm to a child, his parents, family, pets or friends which instills a well-founded fear in the child that the threat will be carried out; or (g) Unlawfully dissects, mutilates, or incinerates a human corpse. (2) The provisions of this section shall not be construed to apply to: (a) Lawful agricultural, animal husbandry, food preparation or wild game hunting and fishing practices and specifically the branding or identification of livestock; (b) The lawful medical practice of circumcision or any ceremony related thereto; or (c) Any state or federally approved, licensed or funded research project. (3) Any person convicted of a violation of this section shall be imprisoned in the state prison for a term of not more than life. (4) For the purposes of this section, "child" means any person under eighteen (18) years of age.
